# **PRESCRIBED FIRE** NEWSLETTER



### CERTIFIED PRESCRIBED BURN MANAGER

The Prescribed Burning Act provides Alabama landowners the right to burn their property while addressing burner liability. This law states "Prescribed burning is a landowner property right and a land management tool that benefits the safety of the public, environment, natural resources, and the economy of Alabama." This statute requires anyone wanting liability protection under the law to become a Certified burn manager, completing 32 hours of in class lecture as well as pass a written test.

One of the purposes of certification is to reduce liability associated with prescribed burning. In order to be protected by the state law, prescribed burns must meet the following criteria: burn must be supervised by an Alabama Certified Prescribed Burn Manager, have a written prescribed burn plan notarized or witnessed before ignition, burn is pursuant to state law as well as obtain a burn permit from the Alabama Forestry Commission. While Alabama is a right to burn state, meeting these criteria will provide liability protection under state law in the case of incidents, unless gross negligence is proven.

According to state law, Alabama landowners can still conduct a pre-

scribed fire without being a Certified burn manager; however, without certification there is no liability protection. Landowners forgoing the certification only need to attain a burn permit from the Alabama Forestry Commission before a burn begins. Burn permits can be obtained by calling (800) 392-5679.

Any landowner, consultant, forester, wildlife biologist or contractor interested in using prescribed fire as a management tool and wishes to become certified should attend one of the Prescribed Burn Certification Classes. This year's class will be held in three different locations across Alabama. Topics include fire behavior, burning methods, safety, planning, smoke screening and state laws. Classes listed meet requirements for certification as approved by the Alabama Forestry Commission.

Typically, classes are offered annually however last year due to restrictions classes were canceled. This year, due to current guidelines attendance will be limited at each location so be sure to register early in order to save a spot.
